You may also download the Affidavit from our website at the address below. The Department must have a properly completed Affidavit by Noon on Friday, May 9 in order to mail a ballot. You may also vote in person in our office from 8:30 am - 4 pm Monday through Friday and until Noon on Monday, May 12. Government issued photo ID is needed to be admitted to the Carvel State Office Building.

NOTICE: Persons appearing to vote must present satisfactory proof of identity and address to the Election Officers in the Polling Place. Persons who do not present satisfactory proof of identity and address, *may*, upon majority vote of the Inspector and the two Judges, be permitted to vote.
