

Tenth Senate District
SPECIAL ELECTION INFORMATION

Voter Registration: To vote in the upcoming Special Election, you must live in the 10th Senate District and be registered to vote by February 15, 2017. If you are not registered to vote, or if you changed your name and/or address and have not updated your voter registration record, contact the Department of Elections at 577-3464 immediately. You may also register or make changes online at <https://ivote.de.gov>.

Absentee Voting: The Department of Elections-New Castle County Office is now accepting requests for absentee ballots for the upcoming 10th Senate District Special Election to be held on Saturday, February 25, 2017. If you are unable to go to your polling place on Election Day, for a reason stated on the Affidavit, you may vote an Absentee Ballot by mail or in person.

by Mail: Call 302-577-3464 to ask that an *Affidavit for Absentee Ballot* (application) for the February 25, 2017 Special Election be mailed to you. If the Department receives a properly completed application before Noon on February 21, it will mail your ballot to you. Ballots must be returned to the Office no later than 8 p.m. on Saturday, February 25, 2017. *NOTE:* Your application may need to be notarized. Read the instructions carefully!

in Person: You must vote in the County *where you live*. ID is required. The Department of Elections-New Castle County Office will be open for absentee voting, for eligible New Castle County residents only, as follows:
